Each participant or for minors their legal guardian must have signed the forms for acceptance of WADA-code 2009 as well as media coverage and accept the WMF anti-doping regulations in current version.
Sport shoes and uniform team sports clothing appropriate for minigolf are required during official practice time and tournament. Only sport hats are allowed.

GROUPS FOR OFFICIAL TRAINING / ACCREDITATION:

The final composition of the groups will be published according to the entries after 31st August 2013 on the organizers website and at the official information board at the location.

Accreditation of all participants (players, coaches and officials) has to be filed immediately after their arrival at Holešov, latest on Monday, 30th September 2013, 18:00.

20:00	victory and closing ceremony
